To address the growing process of metropolization around the world, the Montréal Thematic Meeting on Metropolitan Areas objective was to put forth the role of metropolitan areas in achieving global sustainable urban development goals. If metropolitan areas grow according to well-coordinated and thought out plans, e.g. through integrated participatory planning, solidarity and management approaches, they can help promote communities that are economically, socially, culturally and environmentally viable and equitable. Innovative collaborative partnerships, within and among metropolitan areas, result in sharing areas of expertise needed to overcome common issues and challenges in view of strengthening technical capacity and metropolitan governance, as well as interaction with other government authorities (local, regional and national). During the event, representatives from all level of governments as well as stakeholders shared their experience in overcoming metropolitan challenges by showcasing initiatives relating to metropolitar cooperation.
