

Background information on the event (themes, issues, context).

In the present global transformation, resource and energy constraints make us think about the needs of the future, while new innovations in alternative studies opens up new possibilities & new ideas of Spatial Planning and design. With the possibilities come responsibilities. Architects & Professionals has a responsibility towards the society and will have to meet these challenges through addressing sustainable development & Climate change. The process of Public space led new paradigm of Urban Spatial Planning & Design now requite foresight, economy of resources, to seek and employ new technologies that meet future challenges and lead us to be responsive and responsible for a better tomorrow, towards the implementation of the New Urban Agenda. Panelist were open for discussion on: A) How quality Planning and design can catalyze urban regeneration, create socially and culturally inclusive spaces and promote greening of city. Good design generates equality. Inadequate or poorly designed space becomes segregated. B) Place making is one of the key aspects of urban design. In the process of designing spaces in the cities, it should be more collaborative so that the particular attention can be given to the physical, Cultural and social identities that defines a place. C) Traditions, important to a culture are lost in globalization. Industry driven solutions are being challenged as non sustainable. Time tested traditional systems and process of design and construction needs to be revitalized with the help of technology.


Concise summary of the event proceedings, including key points discussed

responsible urban environments around the globe from USA, Ecuador, Sudan, Oman, Middle east to Bangladesh. Six speakers gave short presentations on their work covering topics ranging from community architecture; diversifying land use; stakeholder involvement; cultural celebration through design and rituals; indigenous architectural practices to be mindful of and conflict resolution for displaced persons. Participatory process in designing and equitable development was a key issue, that was applicable for a project in Bangladesh as well USA. Good practice in partnership with Government and the search for a new paradigm was depicted in the projects of Oman & Bangladesh. The talk also included the new ideas on settlements (formal and informal), new ideas of planning of small & intermediate cities and open spaces lead, place specific quality design intervention. Discussions from the floor amounted to an interest in how architecture can play a role in different regions across the world. Key questions raised from the discussions: 1. Is architecture about changing the social context within which it is constructed or to transform it? 2. How can local resistance be met? 3. What funds are available for alleviation of informal settlements? 4. What would happen if an architect designed a slum? 5. How does one celebrate diversity of humanity through architecture? 6. How can cities be equal for their citizenship? 7. What kind of participatory processes are appropriate for approaching key stakeholders? 8. Replenish: developing metrics to measure economic success in harmony with the local climate

Recommendations that emerged from these discussions.


