Where possible, statements should be provided one day in advance of delivery or at least 3 hours before delivery of statement.

In addition to the representatives of States participating in the Conference and the representative of the European Union, representatives of the following organizations may, time permitting and without setting a precedent, make a statement during the general debate: (a) intergovernmental organizations and other entities that have received a standing invitation from the General Assembly to participate in the capacity of observer in the sessions and work of all international conferences convened under its auspices; (b) other intergovernmental organizations; (c) specialized agencies and related organizations; (d) interested United Nations organs; (e) associate members of regional commissions; (f) local authorities; and (g) non-governmental organizations. In order to provide for maximum participation, interventions should not exceed three minutes.

#### High-level round-table 2

"Ecological, climate-resilient and disaster-responsive cities"

The Co-Chairs of the High-level round-table 2, their Excellencies Camille Gira, Secretary of State at the Ministry of Sustainable Development and Instrastructure of Luxembourg, and Maria Leonor Robredo, Vice President and Chairperson, Housing and Urban Development Coordinating Council of the Philippines, opened the dialogue and made statements.

High-level round-table 2 was moderated by Mr. Aniruddha Dasgupta, Global Director of the Ross Center for Sustainable Cities of the World Resources Institute (WRI), who also made a statement.

The floor then was offered to the panelists, who made statements in the following order: Her Excellency Tone Skogen, State Secretary in the Ministry for Foreign Affairs of Norway; Mr. Denis Coderre, Mayor of Montreal, Canada; and Mr. Henk Ovink, Special Envoy for International Water Affairs of the Netherlands.

An interactive discussion ensued, during which statements were made by the representatives of Switzerland, the Philippines, the United States, Cuba, Portugal, Turkey, Germany, Tajikistan, Uruguay, Colombia and Finland.

Statements were made by: the representatives of the United Nations Office for Project Services; the United Nations Environment Programme; the United Nations Office of the High Representative for Least Developed Countries, Landlocked Developing Countries and Small Island Developing States; the International Federation of Red Cross and Red Crescent Societies; the United Nations Office for Diaster Relief Reduction; and the Secretariat of the Convention on Biodiversity.

The Moderator and the panelists responded to comments made and questions raised during the interactive discussion.

The Chair, his Excellency Camille Gira, Secretary of State at the Ministry of Sustainable Development and Infrastructure of Luxembourg then made a statement and declared High-level round-table 2 on "Ecological, Climate Change Resilient, Disasterresponsive Cities" closed.

#### High-level round-table 3

"Adequate and affordable housing"

The Co-Chair of high-level round-table 3, Her Excellency Judi Wakhungu, Cabinet Secretary for Environment and Regional Development Authorities of Kenya, opened the round-table. The round-table was co-chaired by His Excellency Julián Castro, Secretary of Housing and Urban Development of the United States of America, who made a statement.

The floor was then offered to the panelists, who made statements in the following order: Her Excellency Karla Šlechtová, Minister of Regional Development of the Czech Republic; Her Excellency Paulina Saball, Minister of Housing and Urban Planning of Chile; Ms. Leilani Farha, Special Rapporteur on adequate housing as a component of the right to an adequate standard of living, and on the right to non-discrimination in this context, in the Office of the United Nations High Commissioner for Refugees; and Her Excellency Maria Henriqueta Arantes, National Secretary of Housing of Brazil.

An interactive discussion ensued, during which the representatives of the following participating states made statements: Colombia and the Netherlands.

The representative of the following participating state made a statement: Botswana.

Final confirmation of all room assignments will be given the day before the meeting. To prevent double booking, only the delegation initiating the bilateral meeting should submit the request. Reservations will be accepted for 20-minute durations. It is essential that all requests specify the date and time for each meeting, and include the name and level of both delegations participating in the bilateral meeting. Every effort will be made to keep consecutive appointments of the same delegation in the same room.
